1. Privacy Policy

Your privacy is our priority. All data and content are used exclusively for the functionality of Fiestalbum and are never shared with third parties. Fiestalbum does not claim any rights over your content, and you have full control to delete it at any time.

If you wish to permanently remove all your data from Fiestalbum, go to the Privacy section in your profile settings and follow the instructions. All data and content will be deleted within 24 hours.

Information Collected:

- **Personal Data:** When signing up, we collect your full name, email address, and profile picture. You can modify your name and profile picture at any time. These are displayed in event presentations (along with your photos, videos, guest list participation, likes, and comments).
- **Email Usage:** Your email is used for notifications related to Fiestalbum.com. You will be notified on event ends.
- **Media Storage:** Only the photos and videos you explicitly select and upload are stored on our servers. These files are only visible to guests of the same event. You can delete your own uploaded photos and videos. However, inappropriate content can be reported.
- **Event Organizer Control:** Event organizers have the right to remove any content within their events and to exclude guests if necessary.
- **Location Data:** Location services are only used with your explicit consent for functionalities such as creating an event, connecting to nearby events, and displaying maps.
- **Usage Analytics:** Fiestalbum may collect non-personally identifiable information about app usage to measure and improve performance.

2. GDPR Compliance

Fiestalbum is fully committed to adhering to the **General Data Protection Regulation (GDPR)**. We collect only the minimum necessary personal data and require explicit consent before processing it. Our data protection measures ensure secure handling, and we periodically review our practices to maintain compliance.
